#### 1. Introduction

The first workshop at the Narew Pilot Area was held on 21-22 april 2008 in Wierzba (see Annex 1). The Workshop was attended by altogether 20 invited participants representing different stakeholder groups (see Annex 2).

#### 2. Main issues of the PA, and their importance

There were 12 main issues/factors recognized after applying the card-technique. It was the result of grouping out of 59 individual factors named on all the cards by the stakeholders. The number of individual factors assigned to the particular groups was differing from 1 to 12. The number of the individual issues classified to the main factor is shown below in brackets.

- Ø C1. Flood protection (4)
- Ø C2. Water quality in lakes (3)
- Ø C3. Water-sewage management (12)
- Ø C4. Nature valuable areas (10)
- Ø C5. Spatial planning (4)
- Ø C6. Melioration systems (4)
- Ø C7. Agriculture influence on water status (12)
- Ø C8. Agriculture (2)
- Ø C9. Tourism (4)
- Ø C10. Role of forest (1)
- Ø C11. Transboundary co-operation (1)
- Ø C12. Water retention (2)

According to the results of card-technique the most important factors for the stakeholders were: C3: Water-sewage management, C4: Nature valuable areas and C7: Agriculture influence on water status. Issues classified to these three factors were named by the participants far more often than issues classified to all nine others factors. For four: C1: Flood protection, C5: Spatial planning, C6: Melioration systems and C9: Tourism, out of
